- 6 That unit shall carryout plantation within the premises in at least 33% of the total plot area.
- 7 That unit shall have to achieve prescribed standards as per EP Act, 1986 and shall maintain requisite Pollution Control Measures to achieve prescribed standards all the time.
- 8 That this consent to establish shall be subject to compliance of any direction or order passed by court of law in the matter.
- 9 That if the project cost exceed Rs. 34.09 Lacs, the unit shall take/obtain modification in consent to establish/operate after paying fee as applicable.
- 10 That unit shall comply with the provision of Plastic Waste(Management & Handling)Rules,2016.
- 11 That no plastic carry bags will be manufactured which is banned vide State Government's notification dated 21.07.2010 and clarification vide dated 13.09.2010.
- 12 That this consent shall not reflect the decision of Hon'ble court launched, if any, against the unit under the provision of Plastic Waste (management & Handling) Rules, 2011 & any notification made there under by the Government of Rajasthan /Government of India.
- 13 That unit shall carry out all activities/ operations within covered shed and suitable air pollution control arrangements will be installed to control fugitive air emissions generated from the process or handling of raw materials.
- 14 That the industry shall not carry out any process / production / operation which attracts provision of EIA, Notification, 2006.
- **15** That, not withstanding anything provided hereinabove, the State Board shall have power and reserves its right, as contained **under section 21(6) of the Air Act** to review anyone or all the conditions imposed here in above and to make such variation as it deemed fit for the purpose of compliance of the **Air Act**.
- **16** That the grant of this **Consent to Establish** is issued from the environmental angle only, and does not absolve the project proponent from the other statutory obligations prescribed under any other law or any other instrument in force. The sole and complete responsibility, to comply with the conditions laid down in all other laws for the time-being in force, rests with the industry/unit/project proponent.
