- 5 This consent is not evidence for ascertaining entitlement of land.
- 6 That unit shall provide adequately designed rain water harvesting structures, to recharge the ground water.
- 7 That unit shall carryout plantation within the premises in at least 33% of the total plot area.
- 8 That unit shall have to achieve prescribed standards as per EP Act, 1986 and shall maintain requisite Pollution Control Measures to achieve prescribed standards all the time.
- 9 That unit shall not dig any borewell or abstract Ground Water without prior permission from the Central Ground Water Authority & the State Board and fresh water demand shall be met out by legal supplier of fresh water only.
- 10 That unit shall not discharge any industrial waste water in or outside the premises of the unit and unit shall maintain zero discharge status.
- 11 That water used for cooling purpose shall be kept under recirculation & zero discharge status shall be maintained.
- 12 That unit shall maintain the record of water consumption & submit to the State Board regularly.
- 13 That this consent to operate shall be subject to compliance of any direction or order passed by court of law in the matter.
- 14 That if the project cost exceed Rs. 34.09 Lacs, the unit shall take/obtain modification in consent to establish/operate after paying fee as applicable.
- 15 That you shall comply with the provision of Plastic Waste(Management & Handling)Rules,2016.
- 16 That no plastic carry bags will be manufactured which is banned vide State Government's notification dated 21.07.2010 and clarification vide dated 13.09.2010.

- 18 That the industry shall not carry out any process / production / operation which attracts provision of EIA, Notification, 2006.
- 19 That unit shall not carry out any industrial waste water generating activity i.e. washing without prior permission of the State Board.
- 20 That, notwithstanding anything provided hereinabove, the State Board shall have power and reserves its right, as contained **under section 27(2) of the Water Act** to review anyone or all the conditions imposed here in above and to make such variation as it deemed fit for the purpose of **Water Act**.
- 21 That the grant of this **Consent to Operate** is issued from the environmental angle only, and does not absolve the project proponent from the other statutory obligations prescribed under any other law or any other instrument in force. The sole and complete responsibility to comply with the conditions laid down in all other laws for the time-being in force, rests with the industry/ unit/ project proponent.
- 22 That the grant of this **Consent to Operate** shall not, in any way, adversely affect or jeopardize the legal proceeding, if any, instituted in the past or that could be instituted against you by the State Board for violation of the provisions of the Act or the Rules made thereunder.

This **Consent to Operate** shall also be subject, besides the aforesaid specific conditions, to the general conditions given in the enclosed Annexure. The project proponent will comply with the provisions of the **Water Act** and to such other conditions as may, from time to time , be specified, by the State Board under the provisions of the aforesaid Act(s). Please note that, non compliance of any of the above stated conditions would tantamount to revocation of **Consent to Operate** and project proponent / occupier shall be liable for legal action under the relevant provisions of the said Act(s).
